- WHEREAS the 60th Session Senate of the Student Government Association is compelled 1
- to address the largest modern day mass shooting in America which occurred on October 1st, 2
- 2017 in Las Vegas at the Mandalay Bay Resort and Casino, killing at least 50 people and 3
- 4 injuring over 500 more; and
- WHEREAS Under Nevada law, N.S.R. 202.441-1A, defines an act of terrorism is as "any act 5
- that involves the use or attempted use of sabotage, coercion or violence which is intended to 6
- 7 cause great bodily harm or death to the general population"; and
- WHEREAS an act of domestic terrorism was committed taking innocent lives with a 8
- 9 modified semi-automatic weapon, and
- WHEREAS 11,562 people have already been killed in 2017 due to gun violence meaning 10
- that an average of 42 people have been killed every day since January 1st, 2017 in the United 11
- 12 States; and
- WHEREAS per the FBI 33 active shooter incidents have been perpetrated on various 13
- college campuses and schools around the country from 2000 through 2016 and 14

- 15 WHEREAS the Kansas state government passed a law authorizing concealed carry on
- university campuses across the state starting on July 1st, 2017; and
- 17 WHEREAS per the Kansas Board of Regents 2015 student survey, 57% of WSU students
- voted in favor of repealing the campus carry law and/or delay the law, 43% of WSU
- 19 students voted in favor of the campus carry law; and
- 20 WHEREAS in this survey, 35% of Shockers reported they would be less likely to return to
- 21 WSU due to gun safety concerns; and
- 22 WHEREAS the 60th Session Senate of the Wichita State University Student Government
- 23 Association believes student safety and comfort should be a high priority to ensure students
- 24 can excel academically; so
- 25 BE IT FURTHER RESOLVED that the culture of violence perpetuated in the act of
- 26 domestic terrorism that occurred on the 1st of October, 2017, in Las Vegas, Nevada is not
- 27 condoned by the Student Senate of Wichita State University; and
- 28 BE IT FURTHER RESOLVED that the 60th Session Senate of Wichita State University
- 29 Student Government Association offers its deepest condolences to the families and victims
- 30 of this senseless act of violence; and
- 31 BE IT FURTHER RESOLVED that the 60th Session Senate of the Wichita State University
- 32 Student Government Association recognizes and commends the medical professionals, first
- 33 responders, and heroic bystanders who acted in the wake of the tragedy on October 1st,
- 34 2017; and
- 35 BE IT RESOLVED THAT the 60th Session Senate of the Wichita State University Student
- 36 Government Association encourages the University Police and Administration to review
- 37 WSU policy with updated information from recent mass shootings to ensure the safety of
- 38 students on campus; and
- 39 BE IT FURTHER RESOLVED that University Police and Administration should make a
- 40 priority of informing the student body, faculty, and staff the procedures of what to do in
- 41 case of a shooting on campus; and
- 42 BE IT RESOLVED THAT students are encouraged to contact the University Police at 316-
- 43 978-3450, utilize emergency phones located on campus, or download the Rave Guardian
- 44 Mobile Safety App should they have concerns about their safety on campus; and
- 45 BE IT FURTHER RESOLVED that this Resolution shall be forwarded with respect to
- 46 John Bardo, President of the University; Teri Hall, Vice President of Student Affairs; The
- 47 Wichita State University Police Department, Zachary Zalneraitis, Director of Public

- 48 Relations for Students for Concealed Carry; Stuart Dedmon, Central Regional Director of
- 49 Students for Concealed Carry; Jerry Moran, United States Senator from Kansas; Pat Roberts,
- 50 United States Senator from Kansas; Ron Estes, Member of the U.S. House of
- 51 Representatives from Kansas's 4th district; Oletha Faust-Goudeau, Member of the Kansas
